Local Power Co., Ltd. (the "Company") will promote the protection of personal information through establishing the following personal information protection policy, building a system for the protection of personal information, and ensuring that all employees are aware of the importance of protecting personal information and are fully committed to its protection.

#### 1. Management of personal information

In order to keep clients' personal information accurate and up to date and to prevent any unauthorized access, loss, damage, falsification, or leakage of this data, the Company takes all necessary and appropriate measures such as the maintenance of security systems, continual improvement of managing systems and thorough training of our employees. The Company has strict measures in place to ensure the safe management of personal data.

## 2. Compliance matters, including the acquisition of personal information

The Company complies with the following items in the acquisition, use, and provision of personal information.

### (1) Acquisition of personal Information

To the extent necessary for the operation of the internet-based information provision site (the "Website") managed by the Company, the Company may acquire personal information from general users (the "Users") of this Website or persons who post advertisements on this Website (the "Publishers").

## (2) Purposes of use of personal information

The Company shall not use any personal information that it obtains beyond the scope necessary to achieve the purposes of use specified below, except in cases specified in laws and regulations, or where the Company has obtained the consent of the individual.

- 1. Operation, maintenance, and management of the Website
- 2. Provision and introduction of services via the Website
- 3. Questionnaire surveys for improving the quality of the Website

### (3) Provision of personal information, etc.

The Company shall not provide any personal information obtained based on individual consent to third parties without the prior consent of the individual concerned, except as required by law. With regard to the disclosure, correction, addition, or deletion of personal information or notification of the purpose of use at the request of the person concerned, the Company shall act in accordance with laws and regulations, and respond appropriately to opinions and feedback as a required.

# 4. Changes in the purpose of use of personal information

In principle, the Company shall not change any of the purposes of use specified in the preceding paragraph, except where any individuals concerned give their prior consent. However, this does not apply if the change in the purposes of use is announced in advance, provided that this change can reasonably be deemed to be relevant to the purposes of use prior to the change.

#### 5. Provision of personal information to third parties

If the Company entrusts all or part of the handling of personal information to a third party, the Company shall thoroughly review the suitability of this third party and shall carry out all necessary and appropriate supervision of this party to ensure the safe management of the personal information entrusted to it.

#### 6. Improvement and review of the handling of personal information

The Company shall carry out inspections of the way in which personal information is handled and of management systems and initiatives, and shall continuously improve and review these.

### 7. Disposal of personal information

If the storage of any personal information is no longer required with respect to the purposes of use, the Company shall delete or dispose of this information, and shall carry out this deletion and disposal in the required and appropriate manner to prevent leakage only to the extent necessary to carry out its business activities.
